REPUBLICAN GOVERNMENT (INDEPENDENT BRANCHES OF GOVT):

EXECUTIVE (ch.9), LEGISLATURE (ch.8), JUDICIARY (ch.10), DEVOLUTION (ch11), CONSTITUTIONAL COMMISSIONS AND OFFICES (ch.15). There shall Direct Funding. All Departments and 15% of National Revenue shall be devolved to Counties to promote equitable Development

Civil Service—The Implementers of Legislations and Regime Policies. Managers

LEGISLATURE: (ch.8) Parliament (Senate Represent Counties, and National Assembly (MNA) Represent Constituencies). **SENATE:** 47 Senators elected, 16 women, 2 youth, 2 persons with disabilities nominated by political parties according to proportion of elected senators. **National Assembly** 290 Constituencies. 47 Women shall be elected to National Assembly from counties as their constituencies and 12 nominated MPs to represent special interests. There shall be 349 MNA.

EXECUTIVE.(ch.9) President, Deputy President Cabinet (The President to appoint Cabinet from outside parliament with Approval of Parliament. Shall Reflect the National Ethnic Diversity. The State President shall be the Commander-in-chief Armed Forces. See 130

JUDICIARY. ch.10) **Supreme Court, Court of Appeal, High Court.** The Judiciary consists of the judges of the superior courts, magistrates, other judicial officers and staff.

COUNTY ASSEMBLY. Elected from Wards. *Ex officio* Speaker elected from outside Assembly (178), one-third special members nominated by political parties in proportion by members elected by each party See 90(2), 177(b), one-third is of opposite gender in the Assembly. See 197(1)

City, Municipality, Town, Urban 184

COUNTY EXECUTIVE: The people elect both governor, deputy governor who appoint a committee of ten or not exceeding 1/3 of the assembly members with approval of the assembly. See 179. 1/3 shall be opposite gender. Ensure County Diversity See 175, 197.

All National Govt functions, Ministries & organs shall be devolved to counties, Districts, Locations, Sub-Locations. See Article 6 & 176

By Legislation: Sub-County, Constituency, Wards, Villages,
